Seller reserves the right to decline credit to any Applicant and shall have the right to cancel this Application at any time without notice to Applicant. Applicant authorizes Seller (and its authorized representatives) to (i) obtain and monitor credit reports and/or other information regarding Applicant's business from any source, including but not limited to, all references, bank confirmations and banks listed in this Application and any credit reporting and granting institutions, and (ii) release, disclose and collect information to and from credit reporting and granting institutions and bureaus, financial institutions, Applicant's creditors, or to and from entities that the Applicant have identified on the Application form regarding Seller's credit experience with Applicant. Any references to a granted amount of credit in this Application will not be deemed a limitation of Applicant's liability. The Applicant agrees to hold the Seller harmless for any inconvenience whatsoever caused by either a temporary or permanent withdrawal of credit privileges whether or not the Applicant received any advice of such withdrawal. It is understood and agreed that Payment terms for Seller invoices are thirty days from invoice date (the "Due Date"), unless otherwise agreed to by the parties in writing.
